MENTORS AND OUR MISSION

The mission of the National Conference of Vietnamese American Attorneys (NCVAA) is to promote the education and the professional development of Vietnamese Americans in the legal community, to support research and education on legal issues of significance to the Vietnamese American community, and to provide a national network for Vietnamese American attorneys to exchange ideas relating to the legal profession.

The NCVAA Mentor Program is dedicated to enhancing the skills and careers of Vietnamese American attorneys and law students. The Mentor Program does this by pairing mentor and mentee members in each region of the U.S.

THE MENTOR PROGRAM

I. PROGRAM OVERVIEW

A. The NCVAA Mentor Program

- Matches mentors from a variety of legal fields with mentees
- Law students and young attorneys who are NCVAA members will have an opportunity to join the Mentor Program
- Provide committed, encouraging, motivating, and supportive mentors
- Is a program geared toward the professional and social advancement of Vietnamese
 American attorneys and law students

B. Goals and Objectives of the Program

- Promote NCVAA mission
- Serve as a professional resource for young attorneys navigating the demanding legal practice and students navigating the law school experience [not intended to be a career placement resource for mentees]

C. General Obligations

- One-year commitment to the program (minimum)
- Fulfillment of your mentee or mentor responsibilities, including agreed upon contact with your mentor/mentee (minimum)
- Participation in NCVAA mentor/mentee programming

ROLES, RESPONSIBILITIES, AND EXPECTATIONS FOR THE MENTEE

A. Mentee Roles

The NCVAA Mentoring Program has three main goals for the mentee: (1) supporting the mentee; (2) providing mentors as a professional resource; and (3) helping a mentee achieve his/her goals. Mentees are expected to work with their mentors by taking an active role. The quality of the experience a mentee has with his or her mentor and the program in general will depend partially upon the mentee's efforts. Below are some general roles that a mentee should expect to play.

1. Team Player

- Identify and share your needs and concerns with your mentor
- Be receptive to feedback

2. Planner

- Set realistic goals with your mentor
- Contribute ideas to solving problems, not just ask for answers

3. Communicator

- Don't be afraid to ask questions
- Communicate clearly and effectively; listen and be respectful

B. Mentee Responsibilities

1. Respect

- Respect your mentor's time and confidentiality as if it were your own
- Respond to your mentor's e-mails or calls in a timely fashion. Keep scheduled appointments with your mentor. Do not share a mentor's personal feelings or ideas with a third party unless authorized by your mentor.

2. Communication

- Be clear about your needs and limits
- Discuss preferred method of communication, the best days to be reached, and time constraints

3. Professionalism

A professional relationship should be maintained at all times

4. Evaluation

- Continually evaluate how well you are meeting your goals
- Be committed to self-development

MENTEE PROGRAM EXPECTATIONS

The NCVAA Mentor Program expects all mentees to be committed to the program. We understand that conflicts may arise. Please make every effort to manage your schedule accordingly and notify your mentor immediately of any changes that will affect your meetings, whether in-person or via Skype or telephone. If you cancel or reschedule an appointment with your mentor more than three times in a year, you will not be permitted to continue participation in the program. If at any time you feel you cannot work with your mentor, please contact an NCVAA Mentor Regional Coordinator. The Mentor Program Regional Coordinator will work to resolve the issue or reassign mentees. If you no longer wish to participate in the program, please contact your NCVAA Mentor Regional Coordinator as soon as possible.

MENTEE GUIDELINES

The NCVAA Mentor Program is designed to provide lawyers and students with an opportunity to get to know each other within the context of the legal profession. You will be assigned to a mentor based upon your stated interests and those of the mentors who are participating in the Program. You are encouraged to attend the program's orientation and any regional meetings. The quality of the experience you have with your mentor and the program in general will depend partially upon your efforts. Listed below are a few guidelines to be considered.

- 1. You should make the initial call to your assigned mentor to arrange a meeting in person. If you do not get a response from your mentor within two weeks after initial contact, please contact your Regional Coordinator.
- 2. Do not assume your mentor knows how often you would like to meet or talk. Therefore, feel free to make periodic phone calls to seek advice or to simply talk with your mentor and share any concerns.
- 3. You should share the responsibility for arranging periodic meetings. These meetings will help you get to know each other and enable your mentor to help you more effectively. Manage your schedule accordingly so you are able to keep your appointments with your mentor.
- 4. Take the initiative to contact your mentor and return calls or e-mails in a timely fashion.

Below are some suggestions for activities to do together:

- Meet for coffee, lunch, dinner, drinks, or entertainment.
- Ask your mentor to attend your moot court arguments (if in law school).
- Ask your mentor to attend a Bar Association event or CLE course
- Attend the annual NCVAA Conference.

NCVAA MENTOR PROGRAM Attorney Fact Sheet

Program Overview

If you are considering becoming a mentor you may have asked yourself the following types of questions: How can I have an impact on a law student's or young attorney's life through mentoring? Do I have the time? The NCVAA Mentor Program provides you with the opportunity to make a significant difference in a law student's career with a minimum time commitment!

NCVAA Mentors provide support and advice on how to handle the unique challenges confronting minority law students during law school and early career development. One of the many benefits of the NCVAA Mentor Program is its flexibility. Once matched, mentors and mentees tailor the mentoring relationship to their individual needs and interests.

Who is Eligible?

Any licensed attorney practicing in any legal area may serve as a NCVAA Mentor. The Mentor Program matches Vietnamese American attorneys and law students with volunteer mentors.

What do NCVAA mentors and mentees do?

Because of the busy lives of attorneys and law students, most contact is done via telephone and e-mail. Some mentor/mentee in-person activities include: attending NCVAA events, bar association events, attending court activities, and meeting for lunch, dinner, drinks, or entertainment.

The Honorable Thang Nguyen Barrett

Judge of the Superior Court of California County of Santa Clara

Judge Thang Nguyen Barrett was the first Vietnamese American municipal court judge in California when he was appointed to the bench by Governor Pete Wilson in 1997. When he was elevated the following year to the superior court through court unification, he became the first Vietnamese American superior court judge in California and the first Vietnamese American in the United States to sit on a court of general jurisdiction.

Judge Barrett's judicial experience includes both civil and felony trial assignments. He had served as presiding judge of the appellate division of the Santa Clara County Superior Court, supervising judge of the Palo Alto Courthouse, and assistant supervising judge of the criminal division (Felonies). He is currently serving as supervising judge of the criminal division of the Santa Clara County Superior Court (term to end in January of 2016).

Judge Barrett received his undergraduate degree from American University in 1985 and his law degree from the University of California, Hastings College of the Law in 1988. Prior to taking the bench, he was a deputy district attorney in Santa Clara County.

In 2000, Judge Barrett was selected by New Horizon publication as one of the 25 Vietnamese Americans in the country "who have made significant contributions to the Vietnamese community and to the fabric of American society in the past 25 years." He was a recipient of the Legal Impact Award from Asian Law Alliance, the Freedom Award from Asian American for Community Involvement, and the Unsung Heroes Award from the Minority Access Committee of the Santa Clara County Bar Association. In 2006, Judge Barrett was presented with the Trailblazer Award at the first National Conference of Vietnamese American Attorneys.



Sang N. Dang

Before becoming an attorney, Mr. Dang worked as a System Engineer at Xerox Corporation for nearly 13 years. Mr. Dang received a Juris Doctor degree from Loyola of Los Angeles School of Law in 1998, and a Bachelor of Science degree in Computer Science from the University of California, Irvine in 1986. He is admitted to practice in California, all United States District Courts in California, and the United States Court of Appeals for the Federal Circuit. Mr. Dang reads, writes, and speaks fluent Vietnamese.

Hon. Jacqueline Duong

Judge of the Superior Court of California County of Santa Clara

Judge Jacqueline Duong, appointed by Governor Schwarzenegger on May 23, 2007, is the first Vietnamese American woman appointed to the bench in Northern California.

Judge Duong was born in Vietnam and immigrated to the United States with her family in April of 1975, first to Pennsylvania then, in 1980, to California. She is a graduate of the California public education system, starting with Franklin-McKinley Elementary School, J.W. Fair Middle School, Yerba Buena High School, then graduating Magna Cum Laude from San Jose State University in 1991 with a degree in Political Science. She later obtained her Juris Doctorate degree in 1994 from the University of California, Davis School of Law.

Prior to her appointment, Judge Duong has spent most of her legal career in the public sector. She initially worked in private practice for approximately one year then joined the Santa Clara County Office of the Public Defender for three and half years. She transitioned from criminal to civil practice when she joined the Santa Clara County Office of the County Counsel in 1999, where she worked for eight years until her appointment to the bench.

In addition to her professional accomplishments, Judge Duong has a long history and a wide-range of community service. She has served on a variety of Boards and Commissions, including as a member of the Asian Law Alliance Board of Directors and was a past President in 1999 and 2000, and a member of the Santa Clara County Bar Association (SCCBA) Blue Ribbon Diversity Commission, the KNTV Community Board, the East Side San Jose Community Law Center Advisory Board, the Santa Clara County Domestic Violence Council, and the San Jose Mercury News VietMercury Advisory Board. She was also a coach for the Mocktrial program for her alma mater Yerba Buena High School.

Judge Duong was the Co-Founder and the first President of the Vietnamese American Bar Association of Northern California. In 2006, she spearheaded the inaugural National Conference of Vietnamese American Attorneys attended by more than 150 Vietnamese American attorneys from across the country. Judge Duong is also the Founder of the Vietnamese American Professional Women of Silicon Valley.

Judge Duong has been the recipient of various awards, including the East Side School District Hall of Fame (2011), the SCCBA Women Lawyers Award (2010), the Honor Society of Phi Kappa Phi Distinguished Alumni Award (2009), National Conference of Vietnamese American Attorneys Trailblazer Award (2008), Asian Law Alliance Legal Impact Award (2008), the Vietnamese American Bar Association of Northern California Trailblazer Award (2007), the Santa Clara County Bar Association MAC Unsung Heroes Award (2007), the County of Santa Clara County Executive Unity in Diversity Award (2006), and the Helen Tsao Community Service Award (1999). In 2008, she was named as one of the "Women of Influence in Silicon Valley" by the Silicon Valley/San Jose Business Journal.

Judge Duong is currently assigned to the criminal division conducting felony trials. She has served as the Presiding Judge of the Santa Clara County Superior Court Appellate Division for two years, and presently serves on the state Judicial Council's Access and Fairness Advisory. Judge Duong is a firm believer in giving back to her community through opportunities to mentor students and young professionals.



Amanda Dwight

Amanda Dwight is the owner of Dwight Law Group, an intellectual property law firm in Irvine, CA, focused on intellectual property prosecution and litigation. Ms. Dwight is a graduate of the UCLA School of Law where she was the recipient of two fellowships. At UCLA, Ms. Dwight served as the Chief Articles Editor of the Pacific Basin Law Journal and judicial extern for the Honorable Gary L. Taylor, U.S. District Court of California, Central District. Ms. Dwight also created a program to intake asylum seekers for the Center for Human Rights and Constitutional Law.

Ms. Dwight is co-author of a leading treatise on trademark prosecution law, Trademark Registration Practice (Thomson-Reuters), and the only practice guide in the U.S. concerning trademark examining procedures, Practitioner's Trademark Manual of Examining Procedure (Thomson-Reuters).

Prior to attending law school, Ms. Dwight was a computer programmer and systems consultant for Andersen Consulting (now Accenture) and an in-house systems analyst for Gannet, Co. At Andersen, Ms. Dwight developed distribution control systems for Fortune 500 companies. At Gannet, Ms. Dwight installed and supported advertising systems for over fifty newspapers throughout the country. Ms. Dwight received her Bachelor of Science as an honors graduate from the University of Virginia, McIntire School of Commerce with a major in Management Information Systems and Marketing.



Kim H. Luu-Ng

KLN Firm, Los Angeles

Kim H. Luu-Ng is the founder of the KLN Firm in Los Angeles where she advocates for and represents victims of torture and trafficking in immigration proceedings. She works extensively with detained and non-detained immigrants on asylum, T-visa, U-visa, VAWA, and other violence based matters before US Immigration Courts, the Board of Immigration of Appeals, and the Ninth Circuit. Kim previously worked as a detention attorney at the San Pedro and Mira Loma Detention Centers under the auspices of the Executive Office of Immigration Review's Legal Orientation Program, providing legal orientation to indigent immigrants and coordinating pro bono representation. From 2009 to 2012, she chaired the Refugee Forum of Los Angeles County, a consortium of NGOs, refugee resettlement agencies, and government agencies that advocates for the needs of immigrants fleeing persecution and seeking refuge in Los Angeles County. Kim frequently trains and presents on immigration and human rights issues.

Kim started her legal career as a litigation associate at the law firm Reed Smith LLP. She received her JD and MA in Public and International Affairs from the University of Pittsburgh, and graduated cum laude with departmental honors from the University of Southern California where she studied International Relations and East Asian Languages and Culture. She speaks Mandarin and Vietnamese.


Kim loves to travel and eat her way around the world with her chef husband. They are proud parents of a Yorkshire Terrier named Teddy Roosevelt.



Hon. Jacqueline H. Nguyen

Circuit Judge, U.S. Court of Appeals for the Ninth Circuit

Jacqueline H. Nguyen is a Circuit Judge for the U.S. Court of Appeals for the Ninth Circuit. She was nominated by President Barack Obama and confirmed by the U.S. Senate in a 91-3 vote on May 7, 2012. Judge Nguyen is the first and currently the only Asian American woman on the federal Court of Appeals. Prior to her elevation, Judge Nguyen was a trial judge for nearly ten years. From 2009 to May 2012, she served as a district judge on the U.S. District Court, Central District of California. Prior to that, she served for seven years as a judge on the Los Angeles Superior Court.



Judge Nguyen received her A.B. from Occidental College in 1987. She also received an honorary degree for a year-long study at Waseda University in Tokyo, Japan, from 1985 to 1986. Judge Nguyen received her J.D. from UCLA Law School in 1991.

Judge Nguyen has been active in the legal community, particularly the Asian Pacific Islander American community, for many years. She has served on the board of various bar associations, including the Women Lawyers' Association of Los Angeles County, the Southern California Chinese Lawyers' Association and the Japanese American Bar Association. Judge Nguyen co-founded and served as President of the Asian Pacific American Bar Association from 1999 to 2000.

Judge Nguyen was born in Dalat, Vietnam. She came to the United States at the age of 10 with her family when South Vietnam fell to Communist forces. Judge Nguyen has two children, ages 11 and 13.



Lam Nguyen-Bull

Senior Corporate Counsel - Litigation, Univar

Ms. Nguyen-Bull is a Senior Corporate Counsel for Univar, a leading global chemical distribution company.

Before joining Univar, Ms. Nguyen-Bull was an associate practicing in the litigation group at Garvey Schubert Barer. She was a law clerk to Judge John C. Coughenour of the U.S. District Court for the Western District of Washington, where she worked on civil and criminal matters ranging from environmental cases to intellectual property disputes.

She earned her Juris Doctorate from Yale Law School in 2003. Ms. Nguyen-Bull is the 2010 President of the Vietnamese American Bar Association of Washington, and a board member from 2007-2009. She is also a 2009 Fellow of the Washington State Bar Association Leadership Institute.

At the Yale Law School, Ms. Nguyen-Bull served as an editor of the Yale Law Review, and was very active in the field of law and technology. She worked as a summer intern in the Civil Division of the United States Attorney's Office for the Eastern District of New York in Brooklyn, where she was given responsibility for civil forfeiture and Social Security cases.

Ms. Nguyen-Bull graduated from Harvard University magna cum laude with a degree in East Asian Studies. During and following her undergraduate education, she lived and worked as a business strategy consultant in Paris, Barcelona and Lisbon, focusing mostly on Internet and wireless technology businesses.

Judge Nho Nguyen

Judge of the Superior Court of California in Orange County Adjunct professor, Western State College of Law

Before his appointment to the bench, Judge Nguyen was hired by Attorney General Daniel E. Lungren to serve as a Deputy Attorney General in the California Department of Justice. In that capacity he prosecuted, on behalf of the State of California, people who committed frauds against innocent citizens and consumers. He also represented the State and its agencies in writs and appeals before the various Federal and State trial and appellate courts.

Since July 2000, Judge Nguyen sits as a trial judge at the Orange County West Justice Center (WJC) handling a criminal trial calendar, presiding over thousands of criminal cases, including misdemeanor, serious felony, and three strike cases. When he began his judicial career at the WJC he handled a six month civil trial calendar. During that time he instituted for the first time the posting of tentative rulings on law and motion matters at WJC on the internet and on the front door of his department one day prior to the hearing date. In the civil assignment, Judge Nguyen issued approximately 500 written rulings with detailed factual and legal analysis.

Judge Nguyen has taught at Chapman University School of Law, Whittier College of Law, and Western State University College of Law as an adjunct professor on International Law, Human Rights Law, Trial Practice and Mediation and Arbitration.

In 2001, Judge Nguyen was inducted into the Hall of Fame at Western State University Law School which also named a scholarship for Asian American law students in his honor. In 2002, he was elected by his peers to serve as President of the California Asian American Judges Association. 

The Honorable John M. Tran

Circuit Court of Fairfax County, Virginia 19th Judicial Circuit

On April 4, 2013, the Virginia General Assembly elected Judge Tran to serve on the Circuit Court of Fairfax County. His term started on July 1, 2013. Judge Tran is the first Asian American judge to serve on a Virginia court of record, the first Vietnamese American judge in Virginia and since the founding of Fairfax County in 1742, the 63rd Circuit Court judge to serve on the Fairfax Circuit Court bench.

The son of a South Vietnamese diplomat and an immigrant who found refuge in the United States, he spent his entire adult life in the Washington Metropolitan Area and proudly considers himself a Virginian.

Prior to his appointment on the bench, Judge Tran shaped his trial experience as a state and federal prosecutor in Alexandria, Virginia in the late 1980's and eventually joined the highly regarded Old Town Alexandria litigation boutique law firm of DiMuroGinsberg, P.C.

The diversity of his 29-year career as a trial lawyer was reflective of trial dockets found in state and federal courts throughout the country. Judge Tran has represented businesses and individuals in matters ranging from simple contract disputes to complex commercial and multi-jurisdictional litigation and criminal defense.

Before leaving the practice of law, Judge Tran was an "AV" rated lawyer under Martindale Hubbell, a Virginia Super Lawyer and Best Lawyer in the area of commercial litigation, and inducted into the Class of 2010 Fellow of the Virginia Law Foundation and Class of 2011 Virginia Lawyer's Weekly Leader in the Law.

And in 2008 Judge Tran had also served as the second of only three Asian American substitute judges ever to be appointed in Virginia. As a substitute judge, he sat in the General District Courts and Juvenile and Domestic Relations District Court throughout Northern Virginia.
